The PCSOs were again made aware of the Council's concerns about speeding vehicles. More information about specific times would be useful to determine whether the percentage was high enough to warrant a speed van to be deployed into the area. Previous assessments had identified a higher volume of vehicles but little evidence to suggest that there were a high number of vehicles exceeding the speed limits.

Parking was still a problem in Rhosneigr, the PCSOs confirmed that they would issue advisory notices to those parking on pavements and take action against drivers who obstruct walkways and driveways.

The Council was also made aware of funding streams available for community events etc.

Guests - Graham Morley And Gwenan Owen - Morlais Marine Energy Project

Morlais is a Menter Môn project that involves extracting energy generated by the horizontal tidal stream over an area of 37km2 of sea bed just off South Stack Island (the West Anglesey Tidal Demonstration Zone) and converting it to electricity. The site is one of three in the UK but is the only one going forward. It has the advantage of already having a connection to the national grid (via the Anglesey Aluminum site) and has the potential to be the largest tidal stream energy site in the world with a maximum generating capacity of up to 240mw which is enough to power 180 thousand homes. Menter Môn have a 45 year lease on the site. Funding of 5.6 million pounds has been secured from the Welsh Assembly Government, the European Union and IOACC for the initial stages of the project. The aim is to deliver a project that will provide long term sustainable income that will enable local people to capitalize on economic opportunities, attract new investment, secure renewable energy and safeguard the environment.

There were 12 potential developers prepared to make major investment in the project. They were working on 3 main technology types that were either anchored to the sea bed, floated beneath the sea surface or comprised of floating platforms, not all turbines were the same and there was a possibility of using all three types depending on the location. What goes where will depend on the feedback from extensive consultation. The cables would come ashore by South Stack to a shore side station and run underneath the roads via Porthdafarch, Mill Road, past the Leisure Centre to Parc Cybi and the old Anglesey Aluminum site.

The project group were about to put a paper to National Resources Wales (the body responsible for granting a marine license) and an application for planning consent would be submitted to the Welsh Government in September and hopefully a decision would be made by early 2021. This would be followed by 18 months of off shore work and the first devices should be in the water by 2023. In the meantime the project group will continue to work with environmental and engineering experts, IOACC, Network Rail, Highways etc. and engage with local communities.

A number of questions were asked and Members. They were assured that local workforce would be used as much as possible. There was a possibility of 300 jobs and a further 3,500 full time equivalent indirect workers also involved. Members were also assured that environmental risk assessments were being carried out and that visual impact, tourism, terrestrial and marine fishing etc. will all be taken into consideration as part of the consultation process.

It was noted that it would not be permissible to install a height barrier on the Lakeside parking area, however it was resolved to ask IOACC for time restrictions to be adopted to prevent motor homes parking there between 6pm and 8am.

AK Developments were to carry out further work to tidy up the first chimney. It was also resolved that they should be asked to carry out work on the second chimney.
