4. MATTERS ARISING FROM THE MINUTES

4.1 Toilets:

The work on the toilet doors was outstanding as the repair company and the supplier of the parts were closed for business because of Covid19.

In the meantime Cllr. Summerfield would ask a local electrician to check the power supply to ensure that there was sufficient voltage for a water heater.

4.2 Llanfaelog Village Hall:

The work on the roof was outstanding. The roofer originally quoted £350 plus VAT but he would need to revisit to make sure the work could still be done without scaffolding. The clerk would obtain authority before agreeing to any increase in price.

The work on the clock was on hold because of the Covid 19 'lock down'.

4.4 Football Field Wall:

Cllr. Carnall reported that the boundary wall was now repaired.

4.5 **Library:**

The web designer had quoted £600 plus additional support and maintenance costs of £25 per month (paid annually in advance) for creating a Welsh site. They were not taking on any new work until at least August as most of the design team were on 'lock down'.

There was no 'handout' available for site maintenance but they offered to run a half-day training course for up to 3 people for £180.
